#### Service Description

**Regular:** Our most economical service, price at **\$20.00**, assures the completion of your delivery within three hours. Service requests must be placed prior to 2:00 PM. to insure same day service.

**Expedite:** One hour service is available Monday through Friday between 7:00 AM. and 5:00 PM. for **\$25.00**. Service request must be placed prior to 4:00 PM. to insure same day service.

Aero Speed provides service 24 hours a day, every day of the year. Service after hours, weekends and holidays is assigned to the first available driver and is delivered immediately thereafter. After hour and weekend service is charged at 1.5 times the EXPEDITE rate with a \$45.00 minimum charge. Holiday service is charged at 2.0 times the EXPEDITE rate with a \$65.00 minimum charge.
